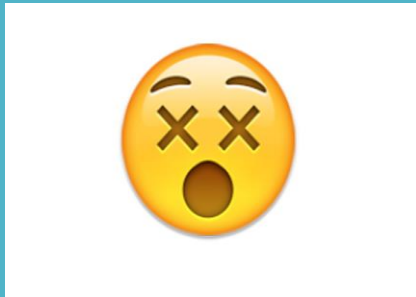


1. Are you a friend online to people or not

So what is Child Sexual Exploitation?

Child sexual exploitation (CSE) is a type of **sexual** abuse in which **children** are **sexually exploited** for money, power or status. **Children** or young people may be tricked into believing they're in a loving, consensual relationship. They might be invited to parties and given drugs and alcohol.

Sending texts or photographs of a sexual nature

Age Limits and Pictures- The Law



What age can you legally have sex?

16

What age can you take a sexy picture of someone?

18

That means if you have a pornographic picture of a person under 18 you can be committing an offence

An offence that can along with other punishments can see then put on the Sex Offenders Register.

Pictures of Yourself- The Law



It is not an offence to take a naked picture
Of yourself as such....

But

Once you have the picture if you are under 18 you have what can be classed as an abusive image
or child Pornography....

Even if it is of yourself!

Sending and Receiving Pictures- The Law



If you know the person you are **asking** to take a sexy picture of themselves is **under 18**

You are now technically soliciting child pornography....

As soon as you **send** the picture to someone else you have committed an offence
Under the Communications Act 2003 – Remember sending indecent material using
A communications network....

You have also distributed child pornography!

As soon as you **receive** the picture you have possession of child pornography....

As soon as you **save** the picture you have “made child pornography”
Yes....even though you did not take the picture.

**An offence that can see them put on the
Sex Offenders Register for a minimum of 10 years**
